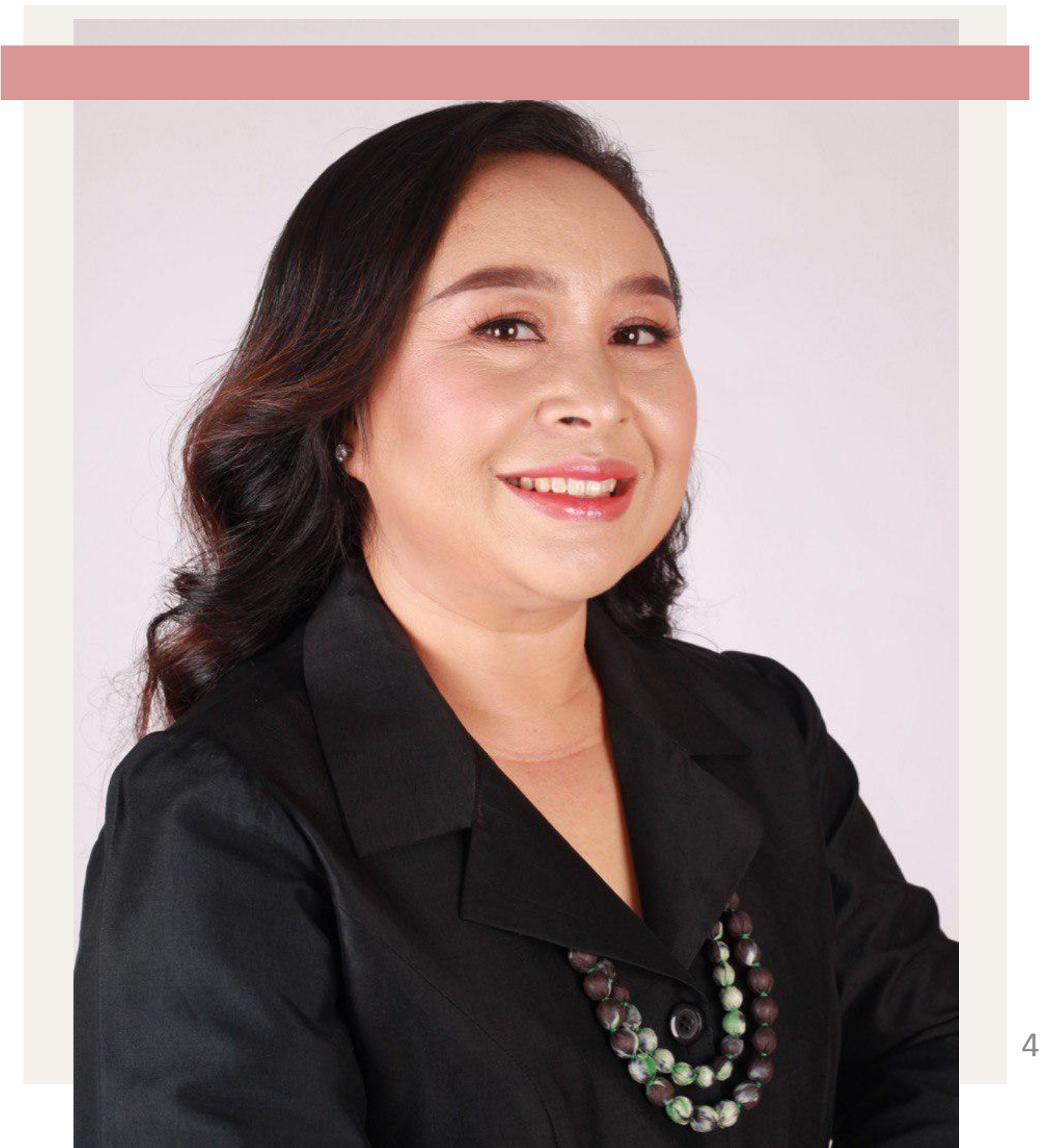

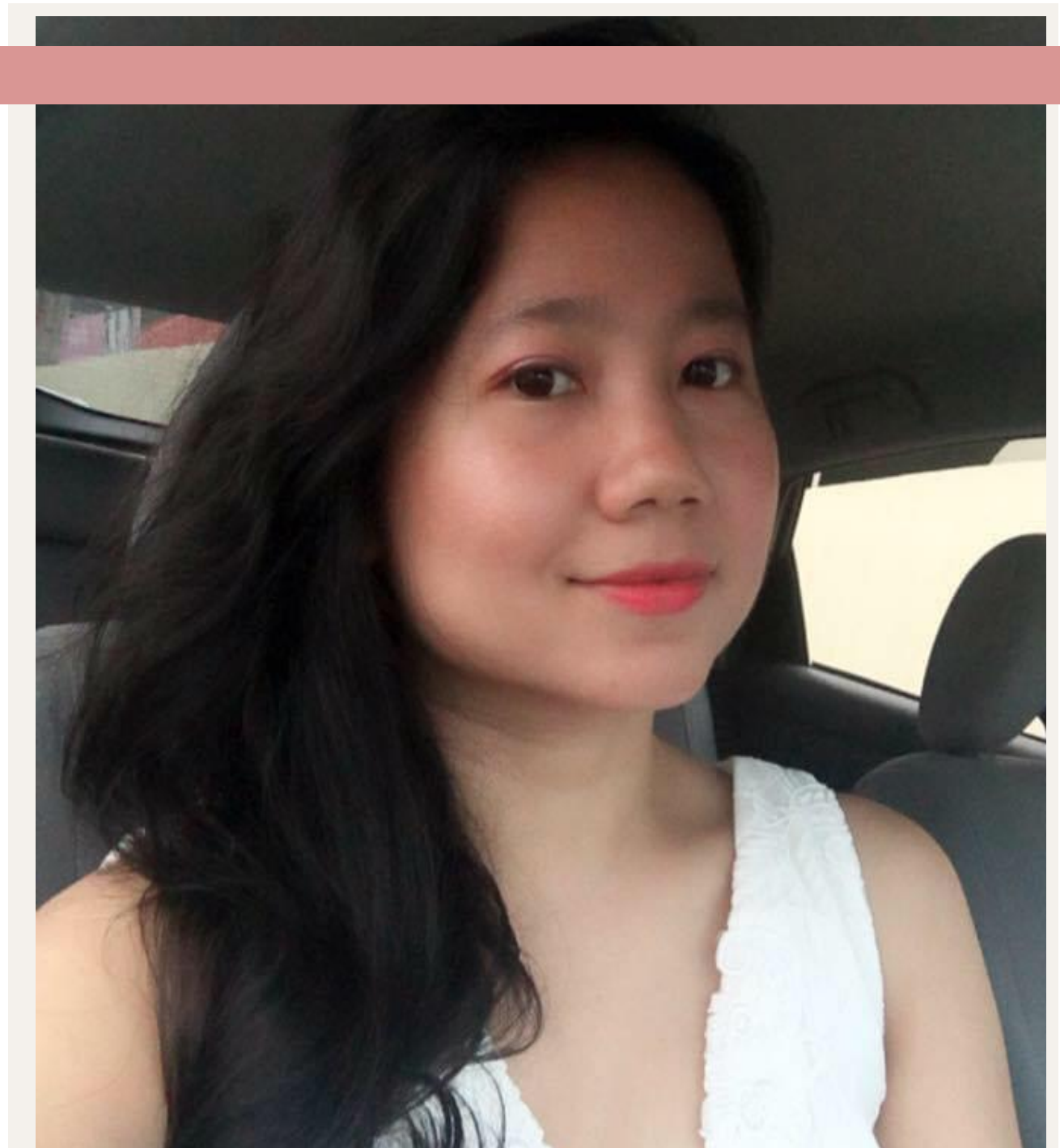

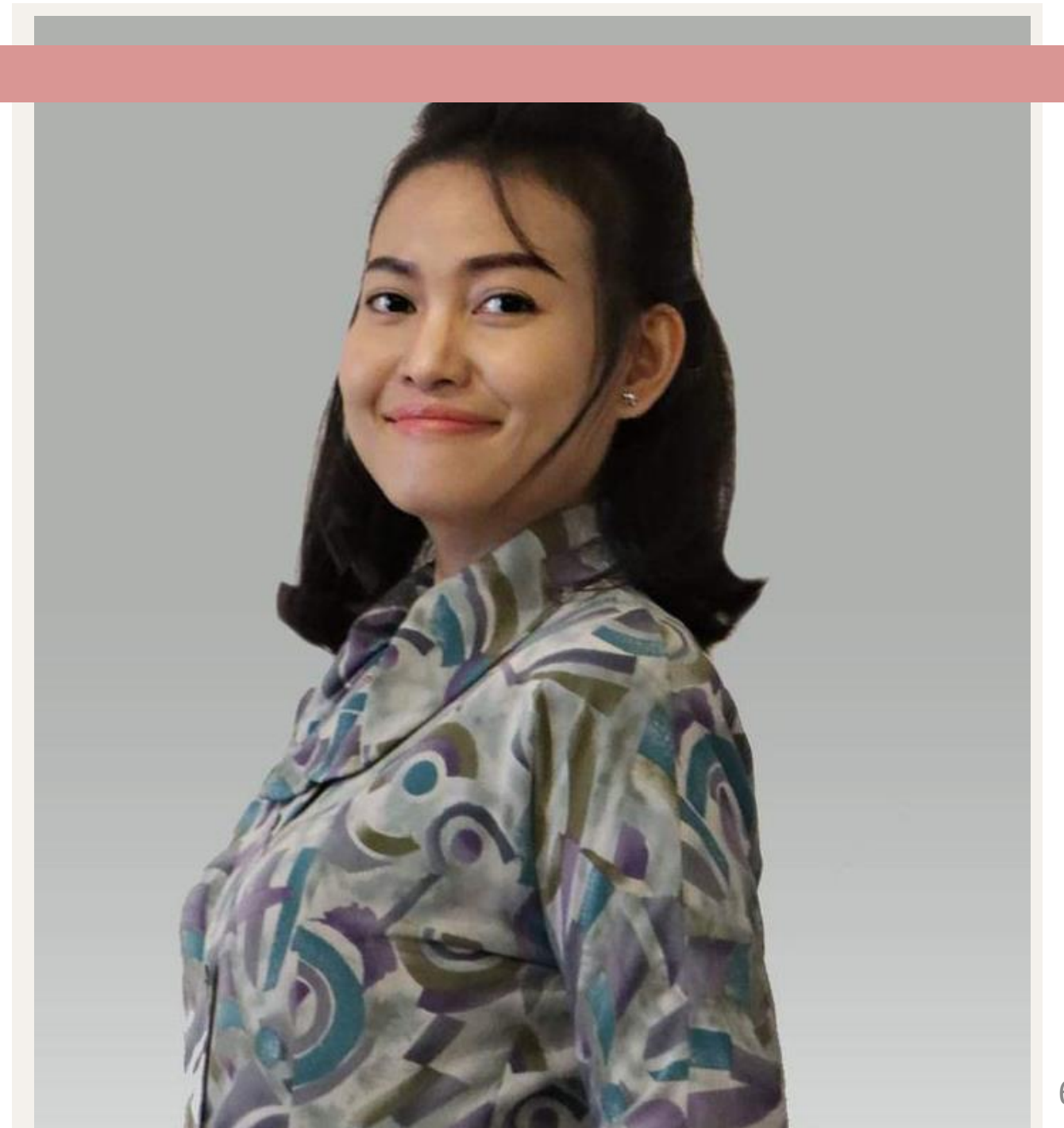

My dream is to have my own small private resort because I love nature and want to support local community projects.
