WICCI Haryana Skill Development Council would like to propose the recommendations/policy interventions in the areas of skill development with respect to the upcoming budget.

*All state skill Development Missions should be directed to Allocate Targets to WICCI in respect to Skill women candidates to uplift their livelihoods and making them employed. This will be an actual example of women empowerment through women themselves.

* More schemes should be launched to encourage women to become Micro & small Entrepreneurs & to promote self employed professionals for non core sectors as well.

* Help-desk should be introduced to help women Entrepreneurs to avail benefits of existing schemes like PMEGP, MUDRA loans etc. Also the process of disbursal of funds should be eased out so that maximum number of women can get benefitted.

* Incubation centres should be formed for easy accessibility of seed funds to promote Entrepreneurship.

* Collaborating with stakeholders to build digital infrastructure for online education .

* Encourage Financial Institutions to run in partnership with local NGOs led by women, by giving benefits

* Tax benefits to women professionals who volunteers to set up or provide education in remote areas.

* Gender inclusive training should be sensitised for overall economic growth and enhanced social support. Women centric residential training centres need to be established in collaboration with Industry and Industry associations at the local Industry cluster.

* Haryana Government should make an online finance portal for online raising of invoices (for all departments in Haryana) which will reduce human intervention with a turn around time of 21 days to release the payments of private vendors.

* With reference to the letter issued by Ministry of Finance dated 12.11.2020 regarding reducing of Bank Guarantee to 3% from existing 5-10% due to slowdown in economy due to COVID 19 (copy attached), Government of Haryana should also release a similar letter in agreement & implement it in Haryana in all the departments by reducing the BG to 3%. This will encourage Training providers to create centres of excellence rapidly through out the state to enhance skill development.
